3. Type of Import :-

- a. Outright purchase if the equipment is procured from abroad on payment of invoice value
- b. If the equipment is procured on lease basis, copy of the Lease agreement to be submitted
- *c*. If the equipment is imported on High Sea Sales basis, Original High Sea Sales agreement to be submitted
- *d.* If equipment is to be imported on Free of cost, loan basis, second hand basis the invoice should clearly state that material are sent on Free of cost, loan basis, Second hand basis.
- *e*. In case Bond to Bond transfer, Bonded warehouse no. & Date should mention in the invoice copy
- 4. Is Capital Goods [CG] approval within the prescribed limit
- 5. Copy of Execution of Continuity Bond (B-17 Bond)
